Subject: Re-assessment for Renewal of Undergraduate Seats (MBBS) to National Capital Region Institute of Medical Sciences, Meerut, for the year AY- 2025-26 in compliance to Hon'ble High Court of Delhi order dated 04.09.2025 - regarding.

Sir/Madam,

Reference is invited to earlier Conditional Renewal order dated 04.07.2025 and subsequent withdrawal order dated 17.07.2025 issued to the College by the Under Graduate Medical Education Board (UGMEB),an autonomous board under National Medical Commission (NMC).

- 2. However, the same was challenged by the college before Hon'ble High Court of Delhi in WP (C) No. 10890/2025. The Hon'ble High Court of Delhi in the hearing held on 22.08.2025, passed an interim order, and directed as under:
 - "16.Consequently, the respondents are directed that the petitioner should be allowed to participate in the ongoing NEET-UG counseling for the academic session 2025-26 and the name of the petitioner shall forthwith be included in the list of colleges as per the sanctioned intake capacity."
- 3. That UGMEB challenged the above interim order dated 22.08.2025 before the Hon'ble Division Bench of High Court of Delhi in LPA No. 563/2025 & CM APPL. 55751-54/2025. The Hon'ble Division Bench, on 04.09.2025, disposed of the above LPA with following directions:
 - "I. The National Medical Commission shall satisfy itself by securing another inspection report from the Expert Committee by 09.09.2025 and thereafter shall take appropriate decision as to whether the petitioner institution is to be

permitted to take the intake of MBBS students for the academic session 2025-26.

- II. If the National Medical Commission is satisfied about the compliance of the statutory norms, it shall ensure that adequate number of students strictly as per merit are provided for admission against the sanctioned seats by the body/authority conducting the counseling.
- III. We also clarify that the direction contained in this order shall have no bearing on the FIR registered by the CBI and the proceedings on the basis of the said FIR shall independently be carried out in accordance with law."
- 4. In compliance of above mentioned directions, the UGMEB requested the Medical Assessment and Rating Board (MARB) to conduct an inspection of the college as per the procedure laid under Section 26 of NMC Act. The said inspection was carried out by the MARB through virtual inspection mode on 08.09.2025. On receipt of above virtual inspection report, the UGMEB got the same scrutinized by an expert on 09.09.2025. As per the expert scrutiny report, following deficiencies were found in the college:
 - As per the virtual inspection, it was observed that in the department of Microbiology, one Assistant Professor is not qualified and the same was informed to the dean virtually.
 - On verifying the AEBAS data, it was seen that some faculty has grossly deficient attendance:
 - a. Anesthesiology Jumaid Ahmad Kantaro (AP)
 - b. Anatomy- Ruchi Sharma (AP)
 - c. OBGYN Bhawana Chettri (AP).
 - Some departments have only tutors. They have NO demonstrator, senior residents (example: Anatomy, Pharmacology). Department of Community Medicine has only one senior resident.
- 5. Subsequently, the virtual inspection report of MARB dated 08.09.2025 and the Expert Scrutiny report dated 09.09.2025 along with AEBAS data of last three months was placed before the Expert Sub-Committee of UGMEB on 10.09.2025. The Expert Sub-Committee of UGMEB examined the above mentioned documents and made a recommendation that the college may be granted conditional renewal for **150** MBBS seats for AY 2025-26 subject to the removal of above mentioned deficiencies within a period of three months.
- 6. In view of the recommendations made by the experts, the competent authority has decided to restore the conditional renewal order dated 04.07.2025 for 150 MBBS seats for the Academic Year 2025–26 subject to removal of deficiencies within 3 months period. Consequently, the earlier order issued by this office vide letter No. Renewal/UGMEB/2023-24/449 dated 17.07.2025, for

withdrawal of renewal of 150 MBBS seats to your institution, is hereby withdrawn with immediate effect.

- 7. In the event that your institution is aggrieved by the decision of the Board, you are entitled to file an appeal before the National Medical Commission under Section 9, Chapter IV of the *Maintenance of Standards of Medical Education Regulations*, 2023 (MSMER, 2023). Any such appeal must be lodged within sixty (60) days from the date of issuance of this communication.
- 8. This issue with the approval of the Competent Authority.
